

## Proceedings Instructions

Dear colleagues,

Thank you for participating at the 10th International Conference on Semiotics entitled “Changing worlds & Signs of the times”. The authors whose abstracts have been accepted for presentation at the conference can submit their full paper for publication in the conference proceedings after double-blind peer review. The conference proceedings will be issued as an ebook with ISBN and pagination. Please, consider the following instructions. The full paper must be submitted (in word form) by **20th of December 2013** on the following email address [semio2013@uth.gr](mailto:semio2013@uth.gr), subject: ***“Full Paper Submission for the 10th International Conference on Semiotics”***.

### **Instructions regarding the formatting of the full paper**

Your full paper should not exceed 4,000 words including tables, figures, notes, references, and appendices, as there is also a limit of 12 pages. Times New Roman font is required with single-spaced 12- point interline spacing; the basic margins of word should be used, that is top and bottom margins should be 2,54, while right and left margins should be 3,18 cm. Full alignment of the whole paper with paragraph indent 0,5 cm is necessary.

The title of the presentation should be bold and centred with lowercase letters. After skipping a line, the first and last name of the author(s) should be written, while in the next line the author(s)' position and the affiliation (if they are available) should be provided. In the next line, the author(s)' email should be included. All the above pieces of information should be centred with lowercase letters.

After skipping a line, the word **Abstract** should be included (bold, lowercase letters, left alignment). In the next line, the actual abstract should follow (italics, single-spaced interline spacing, full alignment). The abstract should not exceed 150 words.

In the next line, 6 **Keywords** should be written (bold, lowercase letters); each keyword should be separated from the other with a comma (lowercase letters).

The titles of the subsections should be in bold, lowercase letters. Please, do not number the sections and subsections.

The in-text citation should include the author's last name followed by the year of publication, which should be written in brackets by order of appearance in the document, e.g., (Gibson, 2011). In case of direct quoting someone else's work, include the exact page number, e.g., (Gibson, 2011, p. 607). The detailed list of references should be given at the end of the paper.

Notes, where necessary, should be numbered successively and placed at the end of the text (endnotes).

Insert figures and tables in the text following reference to them (not at the end of the text or in a separate file). Titles numbered successively should appear above tables or figures. In addition, distinctive graphics or photos should be in jpg or png form.

As noted earlier, the detailed list of **References** should be at the end of the paper (bold, lowercase letters) according to APA 6th edition. More information about citation can be found on <http://www.apastyle.org/> or <http://www.apastyle.org/learn/tutorials/basics-tutorial.aspx>
